Explanation of Responses:

1. On March 2, 2020, the Reporting Person was granted 95,444 restricted stock units ("RSUs"), vesting upon the achievement of certain performance targets. On December 15, 2022, vesting of the Reporting Person's RSUs that would have vested on March 2, 2023 was accelerated at 145% of the performance target, as approved by the Organization & Compensation Committee of the Issuer's Board of Directors (the "Committee"). On February 27, 2023, the Committee certified achievement at 151.1% of the performance target and approved the vesting of additional RSUs.

2. Each RSU represents a contingent right to receive one share of Aerojet Rocketdyne Holdings, Inc. common stock.
